RECOGNITION ORDER

WHEREAS in terms of section 14(1) of the NCTE Act, 1993 Raj Charity Society, Plot No. – NA, Street No – Na, Village – Chandapur, Post Office – Jangiganj, Tehsil/Taluka – Gyanpur, Town/City – NA, District – Sant Ravidas Nagar, Uttar Pradesh, Pin Code:-221310 has submitted on application (Code No. NRCAPP-2161) to the Northern Regional Committee of NCTE for grant of recognition for conducting D.EL.ED. (Additional Intake) Course with an annual intake of 50 (Fifty Only) on dated 28.09.2011 in the name of Ram Dev P.G. College, Plot/Khasra No.- 1338/00421, Plot No:- 1338, Street Number- G.T. Road, Village- Godhana, Post Office- Jangiganj, Tehsil/Taluka- Gyanpur, Town/City- Jangiganj, District- Sant Ravidas Nagar, State- Uttar Pradesh, Pin Code- 221310.

2. AND WHEREAS on scrutiny/perusal of veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution against letter of 7(9), the Northern Regional Committee in its 216th Meeting of the NRC held from Jun, 27th to 28th, 2013, is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the D.EL.ED. (Additional Intake) Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Ram Dev P.G. College, Plot/Khasra No.- 1338/00421, Plot No:- 1338, Street Number- G.T. Road, Village- Godhana, Post Office- Jangiganj, Tehsil/Taluka- Gyanpur, Town/City- Jangiganj, District- Sant Ravidas Nagar, State- Uttar Pradesh, Pin Code- 221310 for conduction D.EL.ED. (Additional Intake) Course of Elementary (Level) of Two Year duration with an annual additional intake of 50 (Fifty Only) from the academic session 2014-2015 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfilment of the following conditions. Total intake of the institution will be 100 (50 Existing + 50 Additional).

- (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- (iii) The institution shall ensure that the required number of academic staff for conducting the course is always in position.

4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.


6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

7. In case if the land is in the name of the Society/trust, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.

8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognitions as under the provisions of Section 17(1) of the NCTE Act.

9. Further, if the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order.

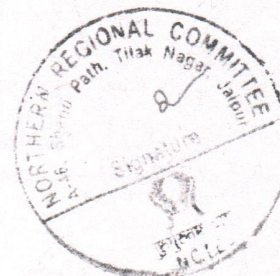
ORDER

Ram Dev Degree College, G.T. Road, Jangiganj, Sant Ravidas Nagar, Bhadohi (UP) 221 310 submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for BTC of Two Year duration in terms of section 15(1) of NCTE Act, 1993.

2. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Ram Dev Degree College, G.T. Road, Jangiganj, Sant Ravidas Nagar, Bhadohi (UP) 221 310 for an annual intake of 50 seats (Fifty Only) (50 seats in the 1st year and the same for the IInd year in BTC course of Two year duration with effect from the academic session 2004-2005 subject to fulfillment of the following before the commencement of the session.

- Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./SCERT is to be completed before the commencement of the session.
- The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commencement of the academic session 2004-2005.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
- Before starting the course the institution should seek prior permission of the competent authority for conducting the exams and approved of the curriculum that they are going to adopt for the course.
- Institutions if starts the training programme without prior approval/permission of competent authority/examining body regarding the curriculum they have adopted and conduct of examination for award of Diploma/Certificate the recognition of such institutions shall stand withdrawn.
- Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.

3. The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / State Govt. / Affiliating body.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like SCERT/ State Government, etc.
5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
